Minutes

Non-Voting Committee Reports

Athletics

- No official report from Athletics. Though it was mentioned that the Trivia night was a huge success on October 22nd. More than \$4,100 was raised toward the \$9,000 goal. The money raised will be used to purchase new uniforms for the 5th/6th grade students and the purchase of the new water fountain/fill station outside the gym.

Pastor Report – Father Don McLaughlin

School year is going well. Impressed with the Trunk/Treat. A lot of energy/spirit in the school and the community. Melissa should be commended for all of her efforts and changes that she has brought forth thus far.

Trustee Report – Matt Gambs (not present)

- Strategic Plan committee moving forward
 - Bonnie Covelli, from University of St. Francis joined us for the meeting. Bonnie has worked with many schools in the dioceses. The Strategic Plan will be a relatively short process. Plan is to have it completed by end of January/beginning of February so the school can begin implementing soon after. Bonnie is very open to talk with people individually.
 - One member from the School Board will be a representative on the Planning Committee (committee will be approximately 10-12 individuals)

- Scholarship
 - We are carrying approximately \$140,000 this year in scholarship aid that was given to our families. The finance committee is going to outline a Standard Operating Procedure for Scholarship Awarding Process at their January meeting for the Board to review and approve.
- Capital Campaign
 - Still interviewing companies to lead. We need to figure out next steps and goals. A feasibility study will be the first step. This study will direct us on the amount of our campaign and who are lead donors are. The feasibility study will cost approximately \$40,000. We are estimating the campaign to be \$8M.

Principal Report – Melissa Santos

- > IOWA scores are in and have been sent home
 - Science Scores are the lowest by far
 - Already on Education Committee radar
 - Vocabulary and Writing are also lower than expected
 - Reading saw some dips
 - These are also noticed across the Diocese
 - Working with Mary Ann Draudt to figure out why and how to fix it
- Huge awards for us in Math
 - o Benet Scholastic Bowl
 - \circ 8th grade team placed 1st in Math with a perfect score
 - o 7th grade team placed 3rd in Math
- Annual Appeal
 - o Being mailed home end of week
 - o Would really like to get 100% participation from both of our Boards, Faculty and Staff
 - Online Giving is available and a follow up on Giving Tuesday (11/29) will be sent
 - Last year, the appeal made \$27,000 (far below what was budgeted)
- Preschool
 - Enrollment up to 28 from 14 in July
 - o Preschool Marketing meeting regularly and working with Young on our rebrand
 - My mentor—early childhood background will be in next week to make some observations as to how to improve our preschool by look, by offering, by structure etc
